The Releasor, with the intention of binding himself/herself, the Releasor's parent, spouse, heirs, legal representatives and assignees, do hereby expressly release, relieve, discharge, and agree to hold harmless UWA and its officers, trustees, employees, representatives, and agents from all liability, claims, costs, demands, judgments, and executions, whether for personal injury, property damage, or otherwise, that Releasor, his/her heirs, legal representatives or agents ever has, now has, or may have, whether known or unknown, against UWA, its officers, trustees, employees, representatives, and agents, created by, arising out of, or in connection with Intramurals or other related recreational activities or any travel or events associated with such activities.

Releasor hereby assumes full responsibility of the risk of bodily injury, death, or property damage due to his/her participation in the activity of Intramurals or other related recreational activities or stemming from his/her participation in Intramurals or other related recreational activities.

Releasor expressly agrees that this Release is intended to be as broad and inclusive as permitted by the laws of the state of Alabama, and that, if any portion is held invalid, it is agreed that the balance shall; notwithstanding, continue in full force and effect. Releasor understands and agrees that the voluntary consent to be bound by the terms and conditions setout herein is a material consideration for UWA's agreeing to offer Intramural Sports or Recreational Activities to the Releasor and but for such agreement no such activity would be available to Releasor by the University of West Alabama.
